# Methods of Study:

#### **Specific Resources:**

The school will provide appropriate instructional materials and personnel necessary to the achievement of the objectives and must include resources that are normally available to all learners on the same terms as the terms on which they are available to all. This includes access to the connectivity and devices adequate to participate in independent study and complete assigned work, including but not limited to a computer, tablet, and/or internet access. If the learner needs additional resources in order to successfully access the educational program, please contact the learner's Coach (Supervising Facilitator(s) of Record). Assignments and specific resources will be designated on the AWR Forms and are incorporated herein.

# Methods of Evaluation:

Methods of Evaluation: Academic evaluations will be designated on the AWR Forms and are incorporated herein. Other acceptable methods of evaluation include but are not limited to Facilitator Made Tests, Learner Conferences, Progress/Report Cards, Chapter/Unit Tests, Work Samples, Observations, Portfolios, Learning Journals, Presentations, Quizzes, Labs, Finals.

# Required to report to their Coach (Supervising Facilitator of Record) as scheduled:

Manner of Reporting: <u>One-on-One, Small Group, Online, Phone, virtual.</u> Time: <u>8am-4pm.</u> Day: <u>M-F.</u> Frequency: <u>At least every 20 days.</u> Duration: <u>Full Year.</u> Location: <u>Various.</u> During these scheduled meetings, assignments may be submitted and the learner's academic progress may be reviewed.

#### **Parent Guardian Communication:**

The charter school will communicate with the learner's parent/guardian (or adult learner) about their academic progress by Reports of Progress (report cards) that are sent home once per semester.

### **Voluntary Statement:**

It is understood that independent study is an optional educational alternative in which no pupil may be required to participate. In the case of a pupil who is referred or assigned to any school, class, or program pursuant to Education Code Section 48915 or 48917, instruction may be provided for a learner through independent study only if the learner is offered the alternative of classroom

#### **Board Policies:**

According to the charter school's Independent Study Policy, the maximum length of time allowed between when the assignment was made and the date the assignment is due is 20 school days. If a learner fails to complete at least 75% of work assigned for one learning period, is not making satisfactory educational progress as defined below, and/or accumulates 20 absences due to insufficient work completion and/or engagement as evaluated by the Coach (Supervising Facilitator(s) of Record), an evaluation will be made to determine whether independent study is an appropriate strategy for the learner. A learner is deemed to be making "satisfactory educational progress" if the learner is progressing toward meeting the goals and/or metrics pursuant to their Personalized Learning Plan and/or their Individualized Education Program (IEP), based on all of the indicators set forth in the charter school's Independent Study Policy.

## **Attendance & Work Completion:**

The Coach (Supervising Facilitator(s) of Record) will grant attendance based on the lesser of the time-value of learner work completion (as listed on the AWR Form) and documented participation in educational activity on each day that school is in session.

#### Tiered Reengagement:

Tiered reengagement will begin for a learner if they do not generate attendance for more than 10% of required minimum instructional time over four continuous weeks of the school's approved instructional calendar, learners found not participatory in synchronous instructional offerings pursuant to Education Code 51747.5 for more than 50% of the scheduled times of synchronous instruction in a school month as applicable by grade span, or learners who are in violation of this written agreement.

#### **Supports and Services:**

The charter school will provide support and academic services necessary to address the needs of learners who are not performing at grade level, or need support in other areas, such as English learners, and individuals with exceptional needs in order to be consistent with the learner's IEP or plan pursuant to Section 504 of the federal Rehabilitation Act of 1973 (29 U.S.C. Sec. 794), learners in foster care or experiencing homelessness, and learners requiring mental health supports. These supports include but are not limited to, access to accommodating software/devices, translation services, access to counselors, and additional educational interventions as needed.

#### **Additional Courses:**

Additional courses may be added to this agreement as needed if the agreement is re-signed and re-dated by all of the necessary individuals.

I have read and understand the terms of this agreement and agree to all provisions set forth. I understand that this master agreement serves as parental consent and must be signed by all parties for each school year before a learner may participate in independent study.
